THEN FINES ARE

CORRECTED O/O/S BRAKE VIOLATIONS = \$250

CORRECTED O/O/S STEERING AND COUPLING VIOLATIONS = \$200

CORRECTED O/O/S LOAD SECUREMENT VIOLATIONS = \$500

CORRECTED O/O/S FOR ALL OTHER VIOLATIONS = \$100

OPERATION OF OUT OF SERVICE AND RAILROAD RELATED OFFENSES

TRANSPORTATION LAW 140 2C (VA thru VC)

140 2C VA

(VIOLATING AN OUT OF SERVICE ORDER) (Traffic Infraction)

FIRST OFFENSE – (FINE) \$3000.00 - \$5000.00

SECOND OFFENSE (FINE) \$6000.00 - \$7000.00

140 2C VB

(PERMITTING OUT OF SERVICE OPERATION OF COMMERCIAL VEHICLE)

COMMERCIAL VEHICLE DEFINED BY SECTION 501 OF NYSVTL

ALL OFFENSES – (FINE) \$3000.00 - \$30,000.00

140 2C VC

(OPERATION OF COMMERCIAL VEHICLES IN VIOLATION OF VTL 1171 & 1176)

NOTE: VTL 1171 (CERTAIN VEHICLES MUST STOP AT RAILROAD CROSSINGS)

VTL 1176 (OBSTRUCTING HIGHWAY-RAILROAD GRADE CROSSINGS)

ALL OFFENSES – (FINE) NOT MORE THAN \$12,000

TRANSPORTATION LAW 14 f OPERATION OF OUT OF SERVICE VEHICLE

FIRST CONVICTION (MISDEMEANOR)

Fine (\$2500-\$5000) and/or Imprisonment (up to one year)

SECOND CONVICTION WITHIN 18 MONTHS (E FELONY)

NOT LESS THAN \$3500 FINE and/or Imprisonment provided in the Penal Law
